



Purchase Agreement

This agreement is for the following: A placement of a puppy from **Manstoppers Kennel** (seller) to _____ (buyer). After making your selection, fill out contract and mail it to us with your deposit. **Deposit's** are a commitment to hold a puppy for you and are non-refundable. Buyer can move a deposit to a different litter if not enough puppies' are available. After receiving the balance, the puppy will be shipped, preferably with a non-stop flight to most major cities.

1. **HEALTH GUARANTEE:** The purchaser agrees to take this dog to a licensed veterinarian of his choice within 48 hours of purchase. If at time of examination it is determined that the dog is not in good health due to illness, the cause being clearly attributable to the seller, the purchaser shall return the dog in exchange for a dog of equal value or credit on another dog. A written diagnosis from the veterinarian must accompany it. If purchaser does not wish to return the dog at this time, then the purchaser is responsible for veterinary expenses which may occur. After the 48 hours period, the new owner assumes all further veterinary bills due to illness, misdiagnosis, ect. The purchaser releases the seller from all future liability upon execution of this contract. We guarantee puppy to be free of congenital defects for one year. If puppy is diagnosed with congenital defect, it will be replaced.
2. **2 YEAR HIP GUARANTEE:** If the dog is found to be crippled from Hip Dysplasia, he may be exchanged for a dog of equal value or credit on another dog. The dog must be x-rayed (evaluated) before 24 months of age, and results reported back to **MANSTOPPERS** within 30 days of evaluation to be valid.
3. **Purchase Agreement:** Purchaser agrees and binds himself to take good and responsible care of the dog, feed and house the dog properly and control the dog on a lead when off the premises to avoid loss by theft, running away, or otherwise, and promptly to give and secure the best attention to the physical and mental welfare of the dog. Purchaser agrees the herein described dog will not be cross bred or used for fighting. On male puppies sold, **MANSTOPPERS**

KENNEL has the right to two stud service for the use of his females. If you decide to sell a dog purchased by **MANSTOPPERS KENNEL**, we would like the opportunity to purchase back the dog or help find a good home for the animal.

Limitations: This guarantee applies to the original purchaser only. Guarantee is void if mistreatment, abuse or neglect is evident in the dog. No replacement will be given if purchased dog has been bred (traceable through registration), neutered or spayed. Registration papers must accompany the returned dog to be eligible for replacement dog. Purchaser is responsible for all transportation cost to and from kennel. A dog that is subject to weight pulling before the age of 1 ½ years of age will null and void guarantee. Breeder is not liable for damage or litigation caused by protection training.

Paypal: If buyer uses PayPal for payment, 3 percent of the payment amount must be added to cover PayPal charges. Any PayPal payment that does not include this 3 percent will not be considered complete.
